Background

- ▶ People with childhood-onset disabilities close to normal life-expectancy
- ▶ Adult life comes along with health issues (eg, pain, fatigue, walking deterioration) and participation restrictions (eg, leisure, employment)

 - ▶ Societal functioning (*social citizenship*)
 - ▶ Inclusion?

- ▶ A dimensional approach
 - ▶ Formal status (*juridical*)
 - ▶ Democratic practice (*social norms, an actor in society*)
 - ▶ Identity (*being part, belonging*)

 - ▶ Information roles
 - ▶ Decisive roles

Strategies

- ▶ Part of citizenship requires Disability Management
- ▶ Five strategies of adults with childhood-disabilities (aged 50 years or older) to deal with health problems while upholding citizenship

Energy
management

'When you go somewhere today, you take a rest day tomorrow to maintain balance.'

Taking initiative

'You are always busy to come up with solutions to make it as easy as possible for yourself.'

Self-help with
support

'For two weeks, we started an experiment with eHealth. [...] with your Ipad, you'll get in touch with the nurse so you can discuss the problem and she asks how can we help you.'

Learning from
peers

'If I had known things sooner, I would have done otherwise. Just as you say about dealing with reduced energy levels. I should have done that 30 years ago. [...] I have already indicated that I want to have an annual check-up in a rehabilitation center ... because I do not really know myself.'

Medical
monitoring

'Peer contact is valuable, you learn from each other. It proves that you're not the only one with questions.'

Energy management & Medical monitoring

- ▶ Information roles:
 - ▶ Observer – How do I feel, am I OK?
 - ▶ Sender – Communicating changes/disruptions
- ▶ Decisive roles:
 - ▶ Manager of disruptions – Taking care and dealing with reduced energy levels/ scheduling visits to healthcare providers / support staff
 - ▶ Consumer – Choosing the adequate healthcare providers / support staff / helping aids

- ▶ **Inter-personal roles:**
 - ▶ Leader – Organizing optimal care and support
 - ▶ Liaison – Maintaining network to optimize care and support
- ▶ **Information roles:**
 - ▶ Observer – Where to find relevant info and resources?
 - ▶ Spokesmen – Advocating your interests and rights
- ▶ **Decisive roles:**
 - ▶ Entrepreneur – Re-inventing ways for care and support
 - ▶ Consumer – Choosing the adequate healthcare providers / support staff / helping aids

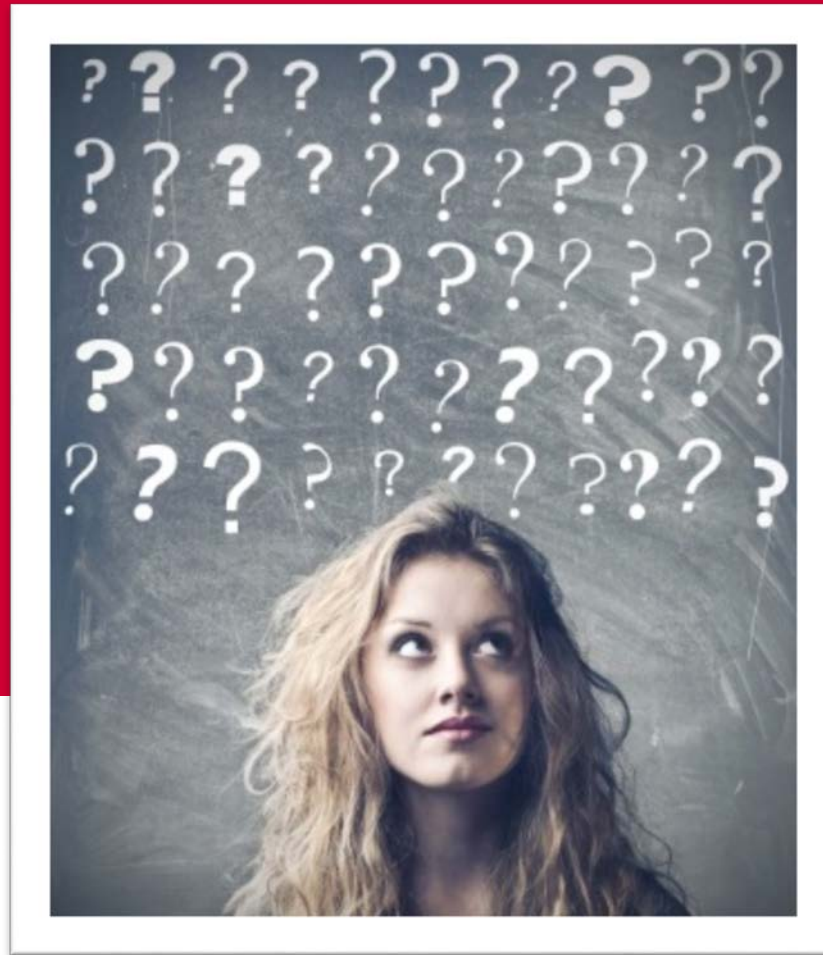
Key findings

- ▶ Adults with childhood-onset disabilities apply effective strategies to stay connected with society and preferred roles (citizenship)
- ▶ Citizenship is partially 'do-able'; Disability management can be a model to support this.

➔ Support should enable control!

Implications

- From a citizenship perspective, policy-makers should acknowledge the required disability management roles to *shape* one's citizenship
- Supportive strategies for these roles need to be developed AND implemented
- More focus on living with disability than on impairments itself
