Personal budgets or direct payments in healthcare

- Has been an initiative of the patients rights movement
- Led to all kind of initiatives for independent living
- Demands accessibility of social institutions
- If necessary with personal assistance
- Which is delivered on the conditions that are determined by the person himself

Some numbers:



- In 2010 2,1 miljard Euro was spent on PGB.
- about 10 % of the total healthcare budget in the Netherlands government
- We have about 150.000 people with a PGB.
- 20 % of those who get care via the AWBZ have a PGB.

Participants in our research

- 49 persons with a PGB
 - 17 parents of youngsters who have a PGB
 - 8 partners of persons with a PGB
 - 2 neighbours of people with a PGB
 - 16 personal assistants
 - 5 pgb consultants

- In total we covered 61 people with a PGB

N = 61

10 market features in relation to PGB

- 1 People with Pgb buy healthcare, do not have an intake but do a job interview with a candidate.
- 2 They negotiate about what, when, etc: your personal plan
- 3 Ask for a proposal/proposition
- 4 They are calculating and by calculating:
- 5 They do not want and buy too much care
- 6 They try to save budget for more difficult times
- 7 They try to find own solutions and be creative with scarcity
- 8 Much more fine tuning between caretaker and caregiver
- 9 They often do not want expensive professionals but less expensive informal carers
- 10 They define quality of care by f.e, personal qualities of carers, flexibility and proximity
